Issue #1: Welcome and Approval of Minutes

Summary of Discussion: Steve welcomed everyone and asked for an approval of minutes. Sally moved to approve, and Charles seconded. Steve said we will cover a lot, two new board member prospects, new board president FY21 and Executive Director search update.

Issue #2: Mission Moment

Summary of Discussion: Pat spoke about Kids Care Plus. We are open and she wanted to update the committee on this. We have 10 kids who come in each day. We have shields on tables for the older kids to support distance learning. The other side of the room is more of a playroom. We started our in-person parenting class and had about 5 people come. These are families who have technology issues. Starting in December, Family Connects Maryland will be able to serve Baltimore County. A month ago, we received an email from a mom from our early program. She sent pictures of her with her 3-year-old and it spoke about how stressed she was before this program and they really helped her. Steve asked what our classes look like. Pat said we have a class every day on zoom and one in the building. We still plan to do an online class when we get back to normal. Doug asked if any programs have been shut down. FCM was for a bit because we could not get into the hospitals. KCP was also shut down for a few weeks but opened in July. We were just about to go into the hospitals again until our recent surge in numbers. Lois said she does not think KCP will be shut down because medical professionals support kids in an organized setting. Hunter asked about the Helpline had any changes. Pat said no big changes but at first, calls were all crisis and now they are getting back to normal.

Issue #3: Review Goals for the Year

Summary of Discussion: Goal: To identify and confirm two new members of the agency's board of directors. Special emphasis must be made to increase diversity (cultural, geography) and increase representatives from corporations and the medical field. The committee brainstormed on strategies to recruit minorities: minority medical associations, Associated Black Charities, outreach to lobbyist, reserving seats for desired members (concern about quota setting). The committee confirmed that it desired voices on the board that represent families we serve; and faces on the board that resemble staff. Pat also reminded the Committee that there were a few programs that require us to have an advisory group. This group is very diverse racially, but largely female (except for J. Meyerhoff) and female. We need to think about different people to help us with this. Pat will talk to John. We are going through another accreditation with HFA.

Issue #4: Board Meeting Attendance

Summary of Discussion: Mary shared the Board engagement/participation grid (filed with minutes) The committee carefully reviewed members falling below the 50% benchmark. Strategies were identified to connect with all those members and make sure they are still connected to the cause. We have had better attendance with the virtual meetings over the past 10 months and we should work on a way to continue that option. Steve said it is important, but we need to be sure all companies keep giving for anyone rolling off the board. It was also noted that the numbers don't tell the entire story: some give tremendous 'sweat capital' others are incredibly generous but are unable to meet meetings. The committee wanted to achieve a balance in these areas. The committee considered creating an engagement score that would include attendance, financial contribution, and shared talent.

Issue #5: Board Terms Expiring

Summary of Discussion: We discussed the board terms who are expiring and assigned members of this committee to reach out and have a conversation with everyone on the list. These conversations should start in the spring.

We did receive two resignations this year, Stephanie McCormick and Adrian Johnson. Stephanie told the committee in confidence that she will be moving to New York this summer. This is a huge loss for us as we will need to find a new chair for the investment committee, and we should replace her with someone from Brown. We will set up time to talk with Stephanie, Jeanne, and Sally about other possible prospects. Kyle mentioned he know Jaimie Steirhoff who is her mentee. Stephanie mentioned Susan Carey, spouse of Geoff Carey. Doug said we need a strategy for brown because this needs to be a person who can have influence, but we should go for someone young. Hunter know someone from brown who went to Roland Park and he can check in with Stephanie to see if it would be a good match. The committee mentioned that Jaimie Steirhoff is a steeple chase rider and could help make a lot of good connections to Charlie Fenwick and that crowd. We will strategize more as a group around Brown. Charles has agreed to contact AJ and conduct an exit interview. He will see if there is anyone from MECU that would be a good fit. MECU is philanthropic in the community and sponsor Great Chefs.

Issue #6: Review Progress with Assignments on Board Prospect List

Summary of Discussion: Terri Marconi and Rich Rosa have been identified as probable members of the Class of FY21. Sally will set up a zoom with Terri and Steve will take the lead with Rich Rosa. The plan would be to have a zoom call with Pat so that we can review the organization, expectations and responsibilities.

The committee reviewed the rest of the prospect list and made changes. Jamie Alban - Sally asked to put Jaimie Alban on the list. Ballard Spahr– Kyle will talk with Tom Hauser about next steps. Jean Wyman – Stephanie Adler brought her name to Nominating. She has served on serval boards and connected in Jewish Baltimore community. Very interested in the board but wants to start as a committee. She is a therapist by trade.

Last committee meeting we spoke about widening the net, asking the rest of the board to ID other people who might be a good fit for the Board. The people that this committee knows run out at some point. We did get a few prospects from that ask. Stephanie identified Jean Wyman. We need to continue to mention that to the board. The committee wants the board to ID one person or contact, Kyle asked if the committee can split the board and make calls to each member asking them to identify a board member or next gen member.

ACTIONS: Committee members will be assigned fellow Board Members for follow up.

Issue #7: ED Search

Summary of Discussion: Sally updated the committee on the Executive Director search to replace Pat. We sent 6 RFP's and received two great responses – Oppenheim and Kittleman. Their fees were similar but have different payment plans. Both groups are not local but they have extensive experience placing Executive Directors in nonprofits. The search will be national and not Baltimore centric. Pat Cronin is familiar with Oppenheim as they have been trying to recruit from TFT for years. The other interesting thing Sally said is the profile of people who will work on the search are very diverse. They might be able to help recruit for the board as well. The firm should be selected by 12/1/2020 by Sally, Charles and Charlene.

Next, they will identify the search committee. This should be a combo of current and past presidents. John Hoey would be a good addition for example. Both firms have experiencing placing Executive Directors.

Sally said having Charlene has made her feel comfortable because she is so well versed in this process. Doug said after we select the firm, they should let us know who should be on the search committee. Politically, if it's too big it's too hard—likely 6-8 members. Doug has heard from some people that want to be on this group, but they might not be that qualified to do so. The Committee expressed an interest in involvement to help select the search committee as the recruiter deems appropriate.

Issue #7: Announcements

Summary of Discussion: Mary reminded the committee we have an Evening to Give Thanks tomorrow and our Board meeting coming up on January 19th.
